100 pc pass in most schools in Ahmedabad

MOST OF the Ahmedabad schools secured a 100 per cent pass percentage as Central Board of Secondary Education (CBSE) declared Class 10 results Tuesday. Among the schools where all the students cleared the class 10 exam are Delhi Public School (DPS) Bopal, DAV International School Makarba, Udgam School for Children Thatlej and Prakash Higher Secondary School in Bodakdev.

At Delhi Public School (DPS)
Bopal school, Rishika Maheshwari emerged as school topper with 99.33 per cent. Out of 445 students who appeared for the examination. 413 students scored distinction, 97 students scored 95 per cent and above and 244 students scored above 90 per cent.
Arshia Adhya and Daksh Jogchand bagged the second position with 99.17 per cent and Garv Srivastava secured the third position with 98.5 per cent. Also,


