employees - Jayrajibhai and Dudhabhai - with iron rods and sticks. One passenger also threw a glass liquor bottle at the three employees from the bus. Then the bus driver tried to speed away and attempted to mow down toll employee Jayrajibhai who was on his motorcycle," said an officer of Amreli police.

"The bus driver continued to drive under the influence of alcohol in a dangerous manner and reached Fiberal railway crossing in Rajula taluka where they created a ruckus with the Rajula police and Home Guard personnel. The driver and passengers then assaulted railway staff at the crossing and forced them to open the barricade and sped away. Later they picked up a fight with a Bolero vehicle driver on route, verbally abused him before stabbing him with a knife. He is in critical condition," the officer added.

According to police, a distress call was made to the Police Control Room in Amreli to end the "spree" after which multiple teams chased the vehicle.

"Amreli police superintendent Niripit Rai ordered check on all roads exiting Amreli and asked police to keep a watch on the bus. A police team of Marine Pipalva police stations spotted the

In Japan hospital for 8 months, Gujarat man brought back home

AMAN from Gujarat, who was in a Japanese hospital for TB and stroke treatment for eight months, was brought to Ahmedabad via Delhi in an ambulance after his family raised over Rs 40 lakh from donors online to facilitate his journey back home, his family members said on Tuesday.

Jayesh Patel (33), a resident of Bhesana in Mehsana district, was in Japan's Ota City on a work permit when he contracted tuberculosis (TB) in October last year and later suffered a stroke (caused due to poor blood flow to the brain), his friends and family members said. He was admitted to a hospital in Shibukawa for the past eight months, they said.

All 31 passengers including the driver, in the age group of 19 to 36 years, were booked under Indian Penal Code 307 for attempting to murder, 326 for causing grievous hurt by dangerous weapon, 353 for assault on public servant, 323 for causing hurt, 504 for intentional insult, 332 for causing hurt to public servant to deter them from duty, 279 for rash driving and sections of rioting as well as sections of the Prohibition Act and Gujarat Motor Vehicles Act.

When his father visited his hospitalised son, all he wanted was to bring him back to India for treatment but could not afford the cost for the same. Jayesh Patel's friend Mukund Patel said, "His family and local friends made an appeal on social media to raise Rs 1.25 crore required to bring him back by an air ambulance and get him treated here.

They ran campaigns on various social media platforms, created a page 'I support Jayesh Patel' on Facebook and received overwhelming response from the public," Mukund said.

A team of doctors from India was required to go there to accompany him in the ambulance. A team of doctors from Ahmedabad went to Japan and under their observation Jayesh Patel was brought to Delhi by an Air India ambulance on Monday.

"From there, he was flown to Ahmedabad where he was admitted in a private hospital for treatment," said Mukund.

Mukund said Jayesh's family was overwhelmed by the support they received from common citizens, who donated generously. Jayesh's younger brother Hardik Patel said they managed to raise Rs 41 lakh.

"My brother and sister-in-law went to Japan in 2018 on work permit. While my sister-in-law returned, my brother was planning to come home in December 2020. On October 5, he was diagnosed with TB and admitted to a hospital. On January 5 this year, he suffered a brain stroke and his condition deteriorated," said Hardik.

"We felt he was not getting proper treatment there so we wrote to the Indian embassy in Japan and also to the Prime Minister's Office," Hardik said.
